The United Nations Office for West Africa and the Sahel - Cameroon-Nigeria Mixed Commission (UNOWAS/CNMC) with its office located in Dakar, Senegal require the provision of repair, maintenance, services and supply of spare parts for 76 units Air Conditioners systems for UNOWAS/CNMC with its office located in Dakar, Senegal.

The contract will be initially awarded for one (1) year with an option for two (1+1) year extensions under the same terms and conditions. The contract extension will be at the UN sole discretion and always be subject to satisfactory performance of the Vendor and UNOWAS budget availability.

The full technical requirements and details will be provided with a formal solicitation document to be issued at a later stage soon after the closing date of the EOI.

SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

1. Interested vendors are requested to submit the following information along with the Vendor Response Form:

1.1.2. List of past and current projects/contracts your company has/is managing (in the last three years) for the services required;

1.3 Company's registration number and registration level in UNGM.

4. Please also note, this is not an invitation for submission of bid or proposals. Its purpose is to identify companies that would be interested to participate in the solicitation when issued.

5. The UNOWAS/GPSS will examine the outcome of this request for EOI and will consider those companies that have expressed their interest providing the required information as to their ability to fulfill requirement.

- C. Your company (as well as any parent, subsidiary or affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
