The United Nations Office for West Africa and the Sahel (UNOWAS) - Route de Plage Ngor, BP23851 Dakar, Senegal - intends to establish a long-term contract for the Provision of Inspection, Maintenance, Repair Services and Spare Parts for Multi-brand Vehicles for an initial period of one (1) year. After satisfactory contract completion of the initial one (1) year, and by mutual consent, UNOWAS may extend this contract for another two (2) terms, each of one (1) year periods (1+1+1).

Services and Parts are divided into seven (7) vehicle brands (for a total of fourteen (14) vehicles):

1. Toyota Prado – Quantity 05
2. Toyota (Pick up) Land Cruiser – Quantity 01
3. Toyota (Armoured) Land Cruiser – Quantity 01
4. Toyota Hi-ace (Minibus) – Quantity 02
5. Nissan Civilian 25 seat Bus – Quantity 01
6. Ford Fusion – Quantity 01
7. Kia Sorento – Quantity 03

The services will be performed by the Contractor at its workshops. In such case, the transportation of vehicles to/from the Contractor locations will be arranged by UNOWAS. In case UNOWAS could not arrange the transportation of its vehicles to/from the Contractor locations, the following services should be provided by the Supplier:

- On-road repair;

- Transportation of UNOWAS faulty vehicles from UNOWAS/CNMC premises to the Contractor workshops;
- Transportation of UNOWAS faulty vehicles from any other destination outside of UNOWAS will be provided by the Contractor.

Other types of service/spare parts may be required on a case-by-case basis.

All maintenance and repair services must be conducted in accordance with manufacturer's standards and specifications for the various vehicles and trucks. The bidder is requested to provide proof of authenticity of being an authorised vehicle dealer for at least one of the seven (7) vehicle brands listed (i.e. Toyota Prado, Toyota (Pick up) Land Cruiser, Toyota (Armoured) Land Cruiser, Toyota Hi-ace (Minibus), Nissan Civilian 25 seat Bus, Ford Fusion, Kia Sorento). All the offered spare parts and products must be OEM (original equipment manufacturer).

The full technical requirements and details will be provided with a formal solicitation document to be issued at a later stage soon after the closing date of this EOI.

### **SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)**

In order to be awarded a Contract/Purchase Order, the bidder/vendor must be registered with the UN Secretariat through the United Nations Global Marketplace (UNGM) for the required level of registration which is "Level 1" before the award of the Contract/Purchase Order.

### 1) Registering as a Vendor with the United Nations
