DESCRIPTION OF REQUIREMENTS				

UNOWAS, Cell in Nouakchott requires the services of a Contractor for the General Maintenance and Repairs of office spaces and equipment located at Tevragh Zeina, Lot 505, Ile Residentielle C, Cercle Trarza, in Nouakchott, Mauritania.

The potential list of UNOWAS Cell in Nouakchott areas to be maintained includes; one (1) Building composed of one (1) ground floor and one (1) first floor in District Tevragh Zeina in Nouakchott. Ground floor has two (2) halls, 1 toilet-room, one (1) kitchen room, two (2) covered garages, one (1) open parking lot, one (1) external toilet, one (1) security guard room, one (1) conference room, one (1) separate office, one (1) garden, the first floor has three (3) separate offices, two (2) bathrooms and one (1) space terrace.

Services to be provided shall include; carpentry, masonry, air conditioning, plumbing and sewage, garbage collection, fire extinguisher maintenance, fumigation and pest control, painting and sanitary appliances replacement, electrical and lighting, inspection and maitenance of floors, tiles and electricity surveillance equipment. Maintenance services shall include corrective maintenance viz emergency maintenance with a response time of maximum two (2) hours and non-emergency maintenance with a response time of maximum forty-eight (48) hours upon a call.

Any works performed or services provided shall have warranty of six (6) months for the workmanship and one (1) year maximum for materials in all works performed in addition to the warranty offered by the equipment manufacturer.

Contractors shall be responsible for the provisions of workforce, all materials, spare parts, consumables and equipment as well as their placement and transportation and any associated costs necessary to perform the Services.

It is preferred that any interested company should have experience in air conditioning systems, plumbing, civil or/ and electrical services as part of its core business. In the event that the interested company does not have experience in one or more of the above services, it may subcontract while disclosing the subcontracting details to the UN. Any subcontractors shall be approved by the UN. The Contractor is fully responsible for all subcontractors (performance and personnel).

The potential contract period shall be initial one (1) year with an option, at the sole discretion of the UN, for two (1+1) year extensions under the same terms and conditions subject to satisfactory performance of the contractor, budget availability among others.

The full technical requirements and details will be provided in a formal solicitation document to be issued at a later stage soon after the closing date of the EOI.
